4a (Code:) (Expenses \$ 405,075. including grants of \$ 0.) (Revenue \$ 0.) THE CITY OF GLENDALE, CALIFORNIA, APPROVED AN INSTALLATION OF A COMFORT WOMEN STATUE IN ITS CENTRAL PARK IN JULY 2013. THE INSCRIPTION ON THE PLAQUE BESIDE THE STATUE CLAIMS THE GOVERNMENT OF JAPAN FORCEFULLY RECRUITED AS MANY AS 200,000 WOMEN FROM KOREA AND CHINA, AND MADE THEM "SEX-SLAVES" TO JAPANESE MILITARY. WE CONSIDER THIS A FALSE ASSERTION, RESULTING FROM FABRICATED HISTORICAL DESCRIPTIONS. WE HAVE A MUCH DEEPER UNDERSTANDING OF THE HISTORICAL EVENTS; THUS, WE HAVE DECIDED TO ASSIST THE PLAINTIFFS IN THE LAWSUIT AGAINST THE CITY OF GLENDALE TO DEMAND THE REMOVAL OF THIS STATUE. WE HAVE SUPPORTED THE LAWSUIT BY PAYING THE COSTS OF THE ATTORNEYS FOR THE PLAINTIFFS.

THE TREATMENT OF THOSE WOMEN CALLED "COMFORT WOMEN" BY THE JAPANESE MILITARY WAS AN IMPORTANT TOPIC.

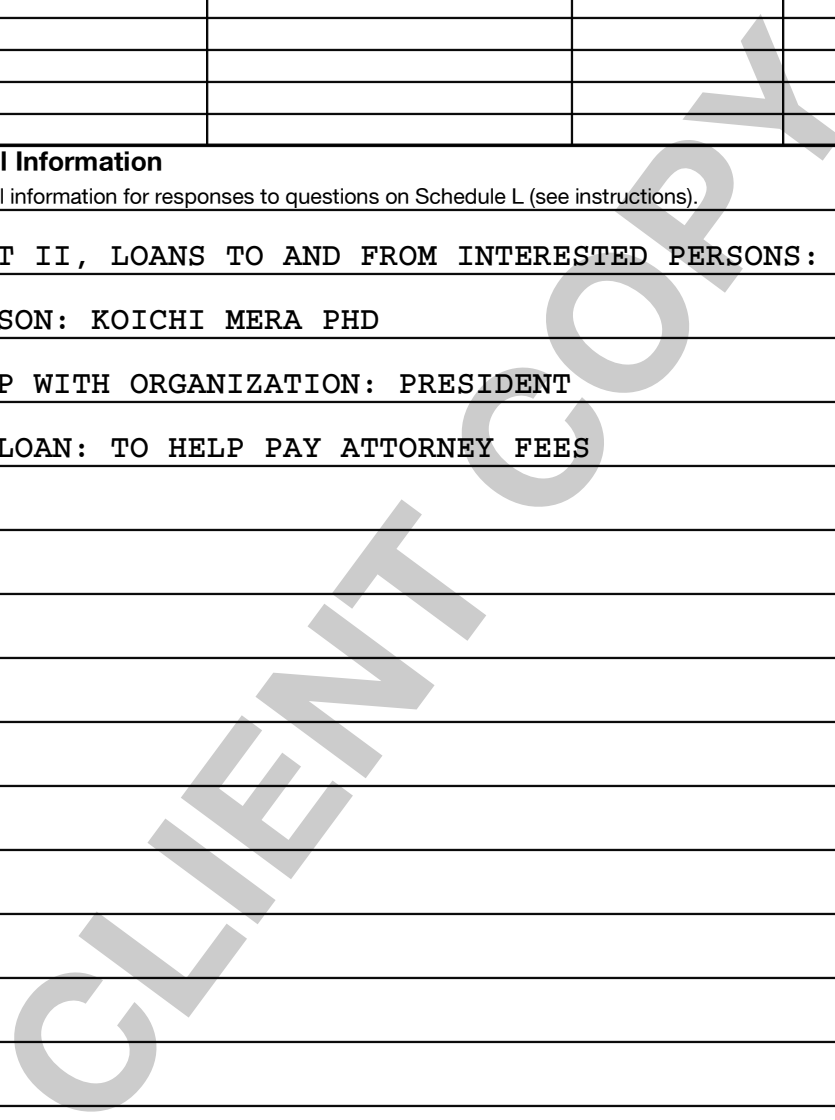

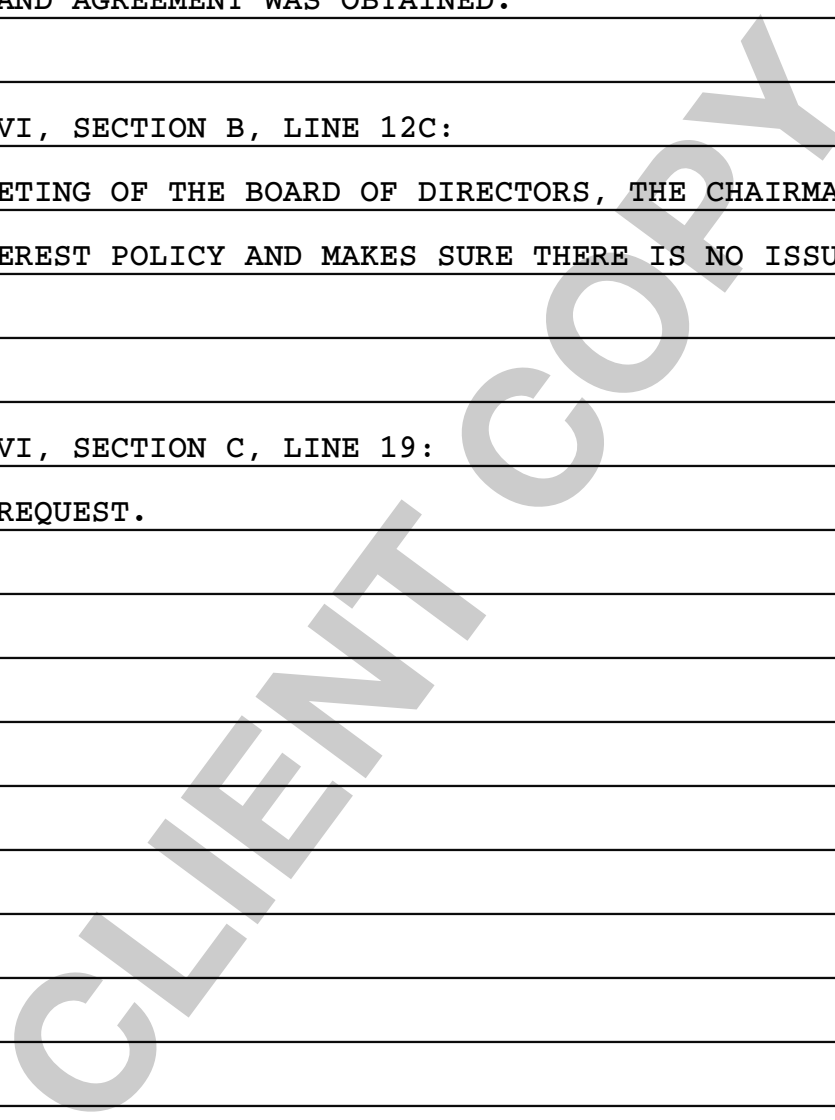
