THE INSCRIPTION ON THE PLAQUE BESIDE THE STATUE CLAIMS THE GOVERNMENT OF JAPAN FORCEFULLY RECRUITED AS MANY AS 200,000 WOMEN FROM KOREA AND CHINA, AND MADE THEM "SEX-SLAVES" TO JAPANESE MILITARY. WE CONSIDER THIS A FALSE ASSERTION, RESULTING FROM FABRICATED HISTORICAL DESCRIPTIONS. WE HAVE A MUCH DEEPER UNDERSTANDING OF THE HISTORICAL EVENTS; THUS, WE HAVE DECIDED TO ASSIST THE PLAINTIFFS IN THE LAWSUIT AGAINST THE CITY OF GLENDALE TO DEMAND THE REMOVAL OF THIS STATUE. 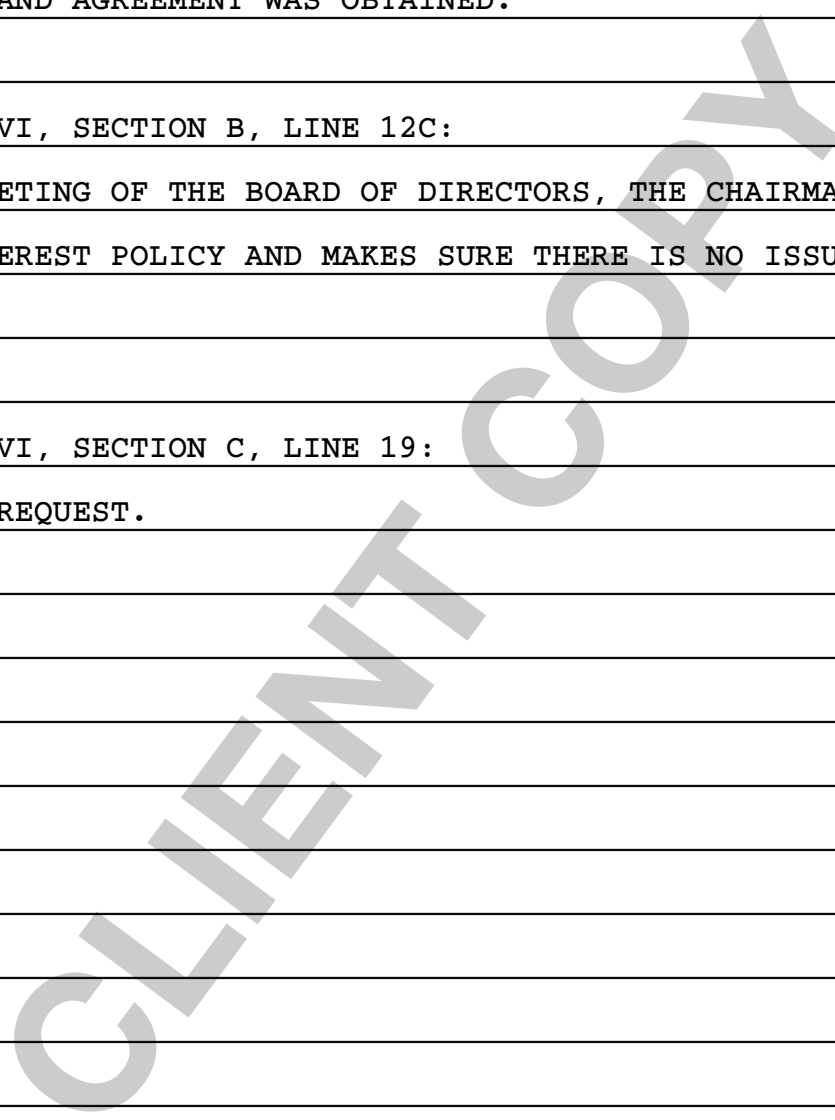
